# New Relief School Notes PTSO meeting 12- Dec-2022

- Concerns about magnet staying at South Meck HS
- Why is CMS not looking at elementary schools as feeder patterns
- Will level of education provided be the same as AKHS in terms of teachers, and curriculum
- Hawk Ridge & Rea Farms being split up again. Families have already been affected once and now impacted again
- What does the scenario look like if all of Hawk Ridge attends AK and not be rezoned
- Are we sure only 5% of teachers from AK will go to the new school
- Need to look at Wake County as CMS keep modeling themselves on this county and yet Wake are always concerned with stability of students. These models shown don't offer stability for our students.
- Have we looked at further growth in the area when making these models
- CMS keeps saying they check residency. This is untrue. Need to vet out every year and ask for proof of residency.
- How can families be made to go to new school and yet people who 'cheat system' and use fake addresses and residency affidavits stay at AK
- How will colleges look at the new school
- Why are students who live closer to AK than new school being made to go to new school
- Why is CMS always selling land off to build apartments, causing greater growth and overcrowding
- City Commissioner needs take responsibility
- Siblings how is the opening of Palisades been and why can't siblings stay together
- Concerns over where the new school is located and impact on local business with poor decisions teenages make and adding extra traffic to all areas
- If we ask Student Placement for reassignment back to AK and provide own transportation will this be granted
- Who votes on school boundaries as they don't make sense
- How does splitting kids their junior year help especially with sports and teacher recommendations for college
- When will CMS board vote more details needed. Don't want voting to happen before all additional scenarios are shown to public. With Rea Farms, neighborhoods that were never in the equation, where suddenly on the night of voting added in without them being aware of it.
